Terms and condition

1.Payment to be made by Pay Order/DD/RTGS in favour of M/s. Jubilant Motorworks Pvt Ltd

2. Price & statutory levies prevailing at the time of delivery are applicable irrespective of initial payment/booking. Prices are subject to change without notice. All taxes cess registration fees TCS (if applicable) insurance premiums and any government levies at the time of invoicing/ delivery shall be borne by the Customer.

3. Customers must obtain an official receipt issued by the Dealer as sole proof of payment.

4. The vehicle shall be delivered only after credit/ clearance of full purchase consideration into dealer's designated bank accounts and post completion of KYC/ documents required by the dealer/ RTO/ financier. Dealer may withhold delivery until such realization and documentation

5. JSW MG reserves the right to change the Order Acceptance Procedure Equipment Specification and Discontinue Models without prior notice. Irrespective of any order placed with the Dealer JSW MG reserves the right at its sole discretion to discontinue alter accept or reject any order/specification without prior notice or liability.

6. The registration of the vehicle and issue of registration certificate is at the sole discretion of the Regional Transport Authority.

7. The delivery of the vehicle is subjected to availability of model and colors at the dealership. JSW MG makes no assurance of delivery timelines.

8. Vehicles/products once sold and/ or invoiced cannot be returned exchanged or cancelled under any circumstances including on the grounds of change of mind colour preference variant change or financing/insurance issues. Invoices once issued cannot be cancelled or modified. Customers are therefore advised to carefully review their booking details chosen specifications financing and insurance arrangements and all other terms prior to delivery and invoicing.

This restriction shall not apply to (i) statutory recalls or safety-related replacements initiated by JSW MG or regulatory authorities or (ii) valid claims covered under the manufacturer's warranty policy. Other than such limited exceptions no refund return or cancellation shall be entertained.

9. Neither JSW MG nor the Dealer shall be liable for delays or failures attributable to events beyond reasonable control (including supply chain disruptions regulatory actions strikes or natural events).

10. Registration certificate copy will be given after Full & Final Payment given to the dealership. Issuance of Registration Certificate is at the discretion of the RTO. Timelines are indicative and outside JSW MG's/ dealer's control. The Customer shall submit all documents and fees required by the RTO/financier. Delays due to Customer/financier/RTO shall not constitute default by JSW MG or the Dealer.

11. The Customer shall furnish accurate KYC PAN (for TCS where applicable) and any additional documents required by the Dealer/RTO/financier.

12. Customer consents to the Dealer sharing necessary personal data with JSW MG and service partners solely for order processing registration warranty activation and after-sales support subject to applicable data protection laws. Marketing communications shall be subject to Customer's opt-in/opt-out preferences.

13. Please collect the order booking form with scheme details signed by the Sales Executive & Sales Manager of the dealership. Only the written booking form/quotation duly signed by the Dealer will be binding on the Dealer.

14. 1% T.C.S applicable on invoice value above 10 lacs. Rates/thresholds are subject to change by law/regulation.

15. On booking cancellation: 100% amount will be refunded by the dealership. Any refund upon booking cancellation shall be processed solely by the Dealer as per its policies. JSW MG has no role or liability in such refunds.
